

Application for Animals, Rabbits or Fowl Permit



No person shall keep or maintain animals as herein defined within the corporate limits of the town of Granby unless such person has a valid permit to do so. All barnyard animals, such as cows, sheep, goats, and any other similar animals, shall not be allowed to be kept in town over 24 hours.

Following application, the premises shall be inspected and if all conditions herein provided are complied with shall authorize issuance of the permit. If a permit is denied, or at the request of the town clerk, a hearing regarding approval of an application may be set before the town board.

A permit shall continue unless revoked. Applications fees of \$10.00 for each horse or mule and \$10.00 for rabbits or fowl are non-refundable and must be paid prior to the issuance of the permit.
