SCHEDULE OF AUTHORIZED AND UNISSUED GENERAL OBLIGATION DEBT:

On November 6, 2007, a majority of the qualified electors of Granby Ranch Metropolitan District Nos. 2 - 8 authorized the issuance of up to \$1,592,500,000 in general obligation debt per District to finance each District's improvements. As of March 24, 2021, the amount of debt authorized but unissued was \$1,592,500,000 for each District. Policy - Requirements

The Office of the State Auditor Local Government Audit Division may accept an electronic submission of an application for exemption from audit that includes governing board signatures obtained through a program such as DocuSign or Echosign. Required elements and safeguards are as follows:
