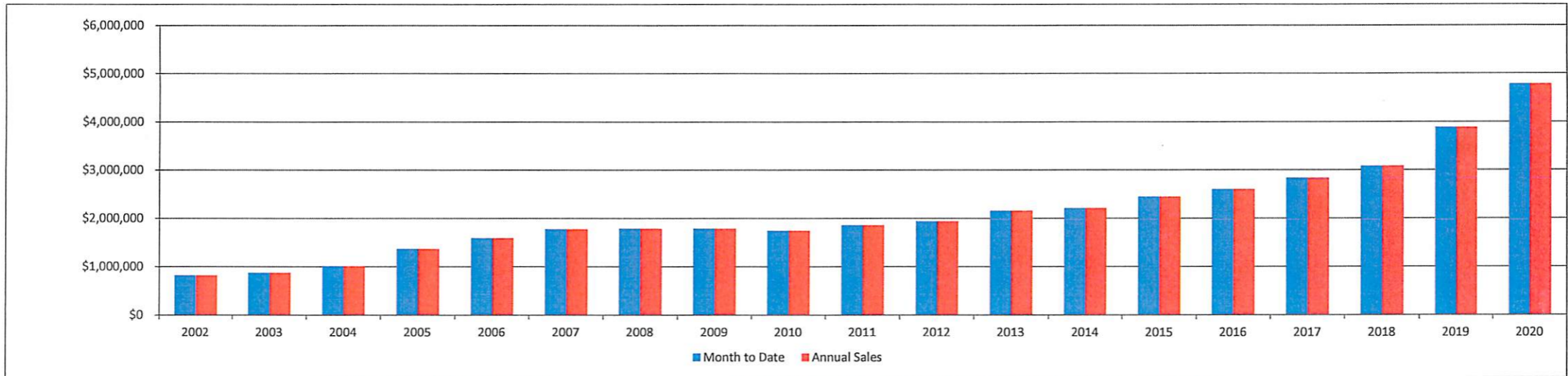

2020 WAS A RECORD BREAKING YEAR!

2020: Sales tax finished in 2020, \$898,608 or 23.13% more than 2019. On-line reporting began June 2019. The fires affected October hunting and closures by \$54,318. Sales tax is still way up over all the previous October's except for 2019. To year to date budget, it is \$921,957 more than budgeted. Year ended for 2020 is 123.9% more than budget. Budget was close to 2019 actual year end. 2020 budgeted sales tax is \$3,861,031.

2019: Twelve months of the year elapsed, the Town is \$807,878 more than 2018 or 26.25% higher. The year was 102% more than revised budget or \$76,231.

It was a great year between tourists, construction, more local shopping and the Wayfair decision.

2018: YTD - twelve months are \$241,945 more than 2017 or 8.54%. YTD is 104% of budget with 100% of year elapsed.

The decrease in February in sales tax is due to the State returning money to businesses, an unusual situation.

2017: Year ended ahead of all previous years. Total budget for 2017 is \$2,617,922. YTD is 108% of budget.

100% of the year has elapsed and revenue is \$237,024 or 9.12% higher than 2016 for the year.

2016 to 2015 ytd was \$153,398 ahead or 6.28% more.

2016 was 12% over the budgeted amount.

2015 - receipts were 111% of the total budget.
